SERVICES AGREEMENT

This Services Agreement (the "Agreement") is made this 01/03/2022 by and between:

PARTIES

1. *Processor* **LLC «AYAKO»**, a company organized and existing under the laws of **Russia Federation** with registered address at *420133, Republic of Tatarstan, Kazan, st. Gavrilova, d. 1, office 332*
2. *Company* **ThreeFourPay LTD** a company organized and existing under the laws of **Cyprus**, with registered address *Boumpoulinas 1, BOUBOULINA BUILDING, 3rd Floor, Flat/Office 31, 1060, Nicosia, Cyprus (No HE 431584)* (Processor and Company hereinafter collectively referred to as the "Parties" and each individually as a "Party")

BACKGROUND:

- A. The Processor facilitates through contractual arrangements the collection and processing of funds by providing technical specifications and software tools from its customers. The funds are received in lieu of goods and services offered by a merchants.
- B. The Company offers services to Merchants and the Processor has agreed to provide technical services to the Company subject to and upon the terms of this Agreement.

1. Definitions and Interpretation

- 1.1 In this Agreement the following words and expressions shall bear the following meanings:

"API"	means the application program interface of the software application used in order to communicate the services under this Agreement.
"Confidential Information"	means all information designated as such by the Discloser (as that expression is defined in Clause 7.1) in writing together with all such other information which relates to the business, affairs, products, developments, trade secrets, know-how, personnel, and suppliers of the Discloser or information which may reasonably be regarded as the confidential information of the Discloser including, without limit, information and data relating to the Parties and their customers, contractors and business partners;
"Consents"	rights, licences, permits and authorisations;
"Merchant"	means a client of the Company who are provided services with using the technical services of the Processor;

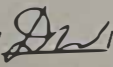
written consent provided that placement and advertisement of genuine employment opportunities by either Party in the labour market shall not constitute a breach of this Clause 13.

14. General

- 14.1 Notices may be delivered by hand or sent by first class prepaid registered post to the address of the Party shown on the first page of this Agreement (attention "Managing Director") and shall be deemed received when so delivered (if delivered by hand during Office Hours), and at 9.00 am on the next Working Day after posting (if posted).
- 14.2 Nothing in this Agreement shall be deemed to create a partnership or the relationship of principal and agent or employer and employee between the Parties nor shall constitute a joint venture or confer any other authority on the Company, whether express or implied, to make any representation or warranty on behalf of or pledge the credit of or otherwise bind or oblige Processor in any way.
- 14.3 The failure of a Party at any time to enforce a provision of this Agreement shall not be deemed a waiver of any provision hereof and no such failure shall prevent such Party from enforcing a remedy as to any subsequent breach. If any provision hereof is adjudged to be unlawful or invalid that provision shall be deemed severed from this Agreement and shall not affect the enforceability of the remaining provisions hereof.
- 14.4 Each Party agrees to execute and deliver to the other or do as appropriate all such other documents, assurances and acts as may be reasonably necessary or desirable to fulfil the provisions of this Agreement or to carry into effect the intentions of the Parties as expressed herein.
- 14.5 Nothing in this Agreement confers or purports to confer on any third party any benefit or right to enforce any term of this Agreement and the provisions of the Contracts (Rights of Third Parties) Act 1999 are excluded.
- 14.6 This Agreement may be executed in any number of counterparts by the different Parties in different counterparts each of which when executed, exchanged and delivered is an original but such counterparts shall be deemed to constitute one and the same instrument.
- 14.7 This Agreement shall be governed by and construed in accordance with English law and the Parties hereby submit to the exclusive jurisdiction of the courts of England.

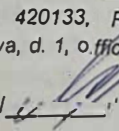
